# **Onam should focus on Vishnu, not Mahabali**

AS MALAYALEES in and outside Kerala get ready to celebrate Onam next week, an article in an RSS magazine has called for a relook into the popular legend behind the festival.

An article in the latest edition of 'Kesari', the RSS's Malayalam mouthpiece, contends that instead of Mahabali. the mythical Asura (or demon)

Vishnu. Unnikrishnan Namboothiri, a professor of Sanskrit at Government Sanskrit College, Thiruvananthapuram, who wrote the article, said there is

little in the epics to substantiate that Onam was observed to welcome Mahabali every year. Mahabali, he said, did not have a paunch and long moustaches, as is depicted popularly.

Supporting the argument, K P Sasikala, president of Hindu

king, Onam should welcome Aikya Vedi (Hindu united front), Vamanajayanthi, or Lord said, "Vamana is the incarnation of Vishnu. In the epics, even Mahabali adores Vishnu. (So) Onam should not be an occasion

for disapproving Vishnu. He should be held as a freedom fighter who freed Kerala from an imperialistic force (Mahabali)." There is little in the epics to substantiate the existing popu-

lar legend that Onam is celebrated to welcome Mahabali, Sasikala said.

Calling the ongoing tradition an attempt to "insult and tarnish

Hindu dharma", which needs to be opposed, she said, "Mahabali was a Vishnu (Vamana) devotee. It is Lord Vishnu is being adorned on Onam festival. Unfortunately, we have made Vishnu a villain in the Onam folklore by depicting him as the force that pushed a popular king to the netherworld (hell)."

Stating that Onam is a secular festival, Congress legislator V T Balram said the attempt to give it a new version would only add communal colour to the festival.

**OPPOSING THE rigid approach** of the All India Muslim Personal Law Board (AIMPLB) on Islamic

marriage laws, the All India Shia Personal Law Board (AISPLB) has suggested the adoption of a "modern nikahnama", seeking changes in the terms and conditions of marriage under Islamic law.

AISPLB spokesperson Maulana Yasoob Abbas, who submitted a draft of the nikahnama (pre-nuptial agreement) to eminent Shia cleric Maulana Kalbe Sadiq, vice-president of AIMPLB, said he has suggested invalidating the instantaneous triple talaq, and provide women the right to divorce.

Abbas also said the stand taken by the AIMPLB in the Supreme Court has "defamed Islam".


