# Tribal group to hold rally against govt benefits to those who have converted

SEEKING TO de-list tribals who have converted to other religions like Islam or Christianity from getting benefits meant for the community, a rally has been organised at Ahmedabad Riverfront on May 27. The Janjati Suraksha Manch, a group of trib-

als, has organised the rally. In a statement, the group stated various tribals have been holding agitations across the country since 2006 with a demand to de-list those who have converted to Islam or Christianity from getting specific benefits. Such people, it added, are getting dual benefits - as tribals and as minorities. While rallies are being organised across the country, a similar march will be held in the city on May 27. The rally – Sinh Garjana 'De-listing Maha Rally' will be addressed by Prakash Uikey, a district judge in Madhya Pradesh. Thousands of tribals from across Gujarat are likely to attend the march, as per the statement.

Meanwhile, a delegation of Dalits from Anusuchit Jati Bachao Manch (AJBM) Monday submitted a memorandum to the Ahmedabad collector opposing any move to provide Scheduled Caste reservation benefits to those Dalits who have converted to Islam or Christianity. If the Dalits converted to Islam or Christianity are given reservation benefits, it would endanger the future of upcoming generations of Dalits, AJBM stated.

Those who have converted get dual benefits - as tribals and as minorities, claims the group which is preapring to hold the rally on May 27

# Video shows dog picking roti meant for patients in hospital ward, triggers action

Multiple entry and exit points are posing a challenge, said a hospital official

EXPRESS NEWS SERVICE VADODARA, MAY 22

A VIDEO from a Vadodara civil hospital, showing a dog picking food meant for patients, has prompted action from the state government. As the clip drew much anger, Gujarat Minister of Health and Family Welfare Rushikesh Patel on Sunday said the state government has already served a notice to the SSG Hospital.

Manoj Agarwal, Additional Chief Secretary of the Health and Family Welfare Department of the state government, has sought an explanation from the SSG Hospital.

Meanwhile, the Medical Superintendent of the hospital has also directed disciplinary action against a Class IV employee for "negligence".

The video, widely shared on social media, shows a stray dog picking rotis from a container meant for patients. The container was seen placed in the passage of a ward of the surgical

block of the hospital during the distribution of meals to patients.

Indian Express, Medical Superintendent Dr. Ranjan Aiyer said the hospital had already initiated punitive action against the Class IV staff last week. "We have served a notice and sought clarification from the outsourcing agency that provides us staff. even before the state government notice was issued. We have also instructed the agency to initiate punitive action against the female employee whose negligence led to this incident," Dr Aiyer said. The hospital serves patients from as far as Madhya

"She has already been taken off duty. The incident took place block about a week ago during

the routine meal distribution in the hospital. The containers should not have been left unattended, knowing that stray dogs do roam around freely," Dr Aiyer

Dr Aiyer added that multiple entry and exit points of the building are a problem. "We are located in an 18th Century structure that has multiple exit and entry points. We also have a problem of strays on campus and it is a separate issue, where we cannot force the civic body to take any action against animals. We have been told that stray dogs have been sterilised and they cannot be relocated from here. The meal distribution is done thrice a day and we have protective covers for all containers, including the casseroles for storing rotis. We have asked the agency to explain why it was left open and unattended on that day. it should not have hap-

He added the video was filmed by a patient last week and brought to his notice before it became public.

# State opposes ex-top cop Sreekumar's discharge plea

OPPOSING the application filed by former Gujarat top cop RB Sreekumar, who is seeking his discharge in a case registered against him for fabricating evidence linked to the 2002 Gujarat riots, the state on Monday filed its written objections through the case's investigating officer before

an Ahmedabad sessions court. According to the prosecution lawyer Amit Patel, the state has primarily opposed on the ground that prima facie sufficient evidence has been brought on record to indicate Sreekumar being part of the conspiracy to allegedly implicate and involve high-ranking officials of the state in the 2002 riots, including the then Chief Minister Narendra

"The affidavits filed before Nanavati Commission contained false information and the contentions raised in the affidavits had already come up before in Zakia Jafri's complaint. Whether

the affidavits were taken as admissible evidence or not, comes at a later stage, but prima facie the information contained in these affidavits (submitted before the Nanavati commission) was false. He attended meetings where the conspiracy was hatched. A statement of a witness is on record to indicate that Sreekumar had issued certain instructions of helping certain persons," said Patel.

With the court yet to begin framing charges in the case, former director-general of police Sreekumar had moved the discharge application earlier this month, submitting that he was innocent and that there was no specific allegation against him in the FIR. The affidavits filed by him made before the Nanavati Commission could not be used to prosecute him as per a Supreme

Court judgment, he had stated. A charge sheet was filed against activist Teesta Setalvad, Sreekumar, and former IPS Sanjiv Bhatt under IPC sections 120 B
