
THE GUJARAT High Court on Monday directed that the Election Commission be made party respondent in the PIL seeking appointment of full-time Director General of Police in the state.

The state government told the court that it is "helpless" in appointing a full-time police chief since the model code of conduct

is in place in view of the upcoming Assembly election. The petitioner Rahul Sharma, a former IPS officer, argued that in "public exigencies" the state can request the election commission for appointment of a regular DGP.
