Ex-Hardik aide reminds govt its promise of jobs to Patidar 'martyrs'

RESHMA PATEL, who had parted ways with Patidar quota leader Hardik Patel and joined BJP in the run-up to the Assembly elections last year, met Deputy Chief Minister Nitin Patel and Minister of State for Home Pradeepsinh Jadeja on Tuesday, and asked them to fulfil the promise of giving jobs to the family members of 14 Patidar youths who were killed in police action during the 2105 reservation stir.

"During the meeting with all the Patidar quota leaders and socio-religious organisations in 2017, the government had promised to give jobs to close relatives of 14 Patidar martyrs (those killed in police action in 2015) will be given jobs by the government. Most of the demands have been fulfilled except this one," Reshma Patel said after meeting the ministers.

"I had discussed this issue at the party level, but somehow things have remained unresolved. So, I thought of reaching out to the government formally. Both Nitin Patel and Jadeja assured me of resolving the same at the earliest," she added. A couple of days ago, she had also written a letter in this regard to Chief

Groundnut procurement to be videographed: Govt

FOLLOWING ALLEGATIONS of irregularities in the procurement of groundnut last year, the state government has decided to record the entire procurement process videographically across the 122 centres of Agriculture Produce Market Committees (APMCs) in the state this year.

Procurement of groundnut at the minimum support price (MSP) will begin from November 15.

Agriculture Minister R C Faldu and Food & Civil Supplies Minister Jayesh Radadiya said that the National Agricultural Cooperative Marketing Federation of India Ltd. (NAFED) and Gujarat State Civil Supplies Corporation will jointly carry out the procurement of groundnut.

The ministers said that this year around 26.92 lakh metric tonne of groundnut production is estimated and the government has decided to procure it at MSP of Rs 5,000 per quintal. They added that the Central government has declared MSP of Rs 4,890 per quintal for groundnut and Gujarat government will add bonus of Rs 110 to it.

"Gujarat State Civil Supplies Corporation will begin procurement of groundnut from 122 procurement centres. All the pro-

available and its footages will be saved. At the procurement centres, the procurement procedure will also be videographed daily. And for surveillance at the centre, a squad will be formed under the leadership of a Class I Deputy Collector Rank officer."

They also stated that the procurement will be done under the Central Government's umbrella scheme, Pradhan Mantri Annadata Aay Sanrakshan Abhiyan (PM-AASHA) for procurement of agriculture produce at MSP. The online registration for it will begin from November 1.

At the procurement centres, one farmer will be able to sell maximum 1,750 kg groundnut per day. And the maximum limit of procurement from each farmer will be 2 hectares. As per the government's estimation, production per hectare this year is likely to remain around 1,836 kg.

Drought relief: Cong questions Dec 1 deadline

Ahmedabad: Claiming that the state government had declared as many as 51 talukas as scarcity-hit after the state unit of Congress launched agitations, the party on Tuesday questioned why the disbursement of compensation to drought-hit farmers was being "delayed" till December 1.

Party spokesperson Manish Doshi said, "Farmers are suffering from drought. They don't have resources to take care of their cattle or meet their requirements as their crops have failed due to drought. Instead of extending financial assistance with immediate effect, the state government is delaying it by more than a month."

"You (the government) have conducted survey and received reports from the field about the extent of damage due to drought. Why this delay? What are you waiting for?" Doshi asked. **ENS**

Voters clash with poll team, two dozen held

Ahmedabad: Police On Tuesday arrested about two dozen people following a clash at a polling booth in Aravalli on late Monday night.

Police said that a mob of about 200 men had gheraoed the primary school at Bhutiya village in Meghraj taluka and attacked the poll officers.

The mob damaged government and private vehicles and injured several policemen. According to the FIR that names nearly 50 persons and 200 unidentified accused, polling for panchayat seats was over at 5 pm, but a group of people who were still waiting in the queue demanded that they should be allowed to caste their votes.

But the police team sent them back. The FIR stated that three hours later, the mob attacked the school, pelted stones at the police teams, leaving several policemen injured. **ENS**
