# AAP worker attempts suicide after 'threats by party leader'

AN AAP worker attempted suicide on August 13 after allegedly being mentally harassed by a party leader, against whom she also lodged a complaint of extortion.

According to police, Sapna Rajput, a resident of Akash Dastan society in Dheeran and native of Uttar Pradesh, had allegedly attempted suicide by consuming overdose of sleeping tablets and also cutting off her right-hand wrist vein.

She was taken to SMIMER hospital by her husband Ajay Rajput, and is presently out of danger.

Sapna, in her complaint with Pandesara police station on August 13 night, had alleged that she had received a call from AAP leader Gautam Patel, also a resident of Jalam society in Pandesara, a couple of days ago. Patel had heated exchange of arguments with Sapna Rajput over some party work issues in ward number 30 in an area in Surat.

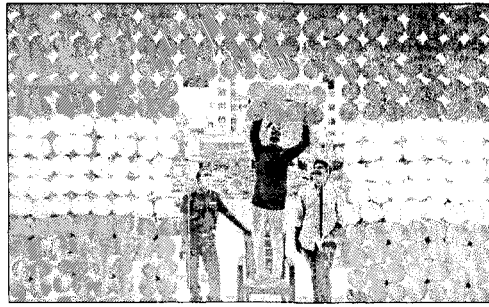
Patel allegedly told her that her husband Ajay Rajput had

taken Rs 4,000 one-and-a-half year ago, on interest, for some work and had till date not repaid the money. Sapna along with her husband had gone to Gautam's office in Pandesara and returned amount, to which Patel demanded a total amount of Rs. 10,000, which she paid, including interest.

According to Sapna, Patel had again called her up on August 13, and threatened her of finishing off her political career. She then attempted to end her life, said Pandesara police.

On the basis of Sapna's complaint, Pandesara police on August 13 booked a case filed against Gautam Patel under IPC sections 289 (extortion), and sections 40 and 42 of the Gujarat Money Lenders Act 2011.

Pandesara Police Sub-Inspector J K Desai said, 'Sapna was under depression over the threat given by Gautam Patel. She had even paid the loan amount with interest to Gautam, even though he continued to harass her. The condition of Sapna Rajput is currently out of danger. We have sent our teams to arrest Gautam Patel and he has gone underground.'

# Seven Asaram followers found guilty of rioting in 2008 case

MORE THAN 12 years since journalists were attacked by followers of rape convict Asaram Bapu, a Gandhinagar magisterial court on Friday convicted seven persons to one year of imprisonment for rioting and causing injury.

In July 2008, followers of self-styled godman Asaram Bapu, who now stands convicted on rape charges, attacked a group of journalists with sticks, who were outside his ashram in Motera, cov-

ering a bandh called in protest against the death of two minor boys who were students at the ashram's gurukul. The attack had taken place on the day of observance of 'Gauranama'. In the verdict pronounced by the additional chief judicial magistrate PK Gadgil on Friday, a detailed order of which is awaited, seven persons were found guilty under IPC sections 147 (punishment for rioting), 149 (Every member of unlawful assembly guilty of offence committed in prosecution of common object), and 323 (punishment for voluntarily causing hurt). A total of five

criminal complaint applications by the prosecution — state of Gujarat — were before the magistrate's court. According to a lawyer dealing with the five cases, all accused in four of the applications were acquitted of the charges while in the fifth case, of the 19 accused, seven were convicted and 12 others acquitted of the charges. The seven accused who were convicted were also granted bail by the magistrate's court.

"The mob involved more than 50-60 people. The acquittal of the accused was primarily on the ground that it could not be determined if they were at the site of the offence or not. Even if the presence of some of the accused could be determined, the location of offence, it could not be determined from the evidence or prosecution witnesses if they were involved in the commission of offence," said the lawyer. The state government was represented by public prosecutor Ujjwal Patel while the accused were represented by advocate BM Gupta.

# CM says no need to die for nation, live for it

THERE IS no need to die for the nation, said Chief Minister Vijay Rupani while speaking at Junagadh on the eve of Independence Day celebrations on Saturday.

"On the eve of Independence Day, our Gujarat should become divine, safe, prosperous and remain culturally rich. The fame of Gujarat should spread all over the world," said Rupani while addressing a cultural event organised by the district administration.

"I hope that during this celebration of 75 years of independence, Gujaratis will take various resolutions. Now there is no

need to die for the nation; we need to live for the nation. Whatever we do should keep our nation in mind. We should aim at making 'Ek Bharat, Shreshtha Bharat', he added. Pointing out to Junagadh

was one of the three regions including Hyderabad and Kashmir that wanted to join Pakistan, Gujarat Governor Acharya Devraj who also spoke at the event said, "Today when India is celebrating 75 years of independence, when the entire country is rejoicing, Junagadh has been chosen for the same programme (independence day celebrations) by chief minister."

Among the dignitaries honoured during the event was freedom fighter Labh Shankarlal Dave. During the event, Rupani also announced Rs 2.5 crore special grant for the Junagadh Municipal Corporation, an additional Rs 2.5 crore for the district panchayats and Rs 2.5 crore to all the municipalities in the district.

# Nargol port project on, to generate jobs, says Rupani

CHIEF MINISTER Vijay Rupani talked about his government's plan to develop Nargol port on the sidelines of the inauguration of 'Ram Mahotsav' in Valsad district on Saturday, Rupani said. "A mega port will be developed and this entire area will be well developed and employment will be generated. The government has moved ahead with this Nargol port project. If anybody has a problem and if it's genuine, our doors are open. The government will not come under any pressure of false talks. We will give importance to development." Nargol village panchayat

had in July, passed a resolution to oppose the port project.

In Valsad Rupani inaugurated a 'Maruti Nandan Van' an urban forest near the Nargol beach where the state government is planning to build a green field port. "Last year we had built a 'Ram Van' in Rajkot... This was inaugurated on the day when the temple in Ayodhya began," Rupani said. Speaking at the event Rupani said, development is possible in Gujarat only if a 'pollution-free' system exists. "Along with development, Gujarat is concerned about its environment. The government is also so concerned about wa-

ter. Sustainable development is only possible when a pollution-free system exists," Rupani said while addressing the event.

Rupani said under the forest department's social forestry programme — aimed at increasing tree-cover outside forest areas — the state government has targeted 15 crore trees. "In the past, there were only 25 crore trees (in 2003), that were part of forest department's social forestry programme. Now we have increased to 35 crore trees. There is a 15 per cent growth," he claimed.

Ganpat Vasava, state forest minister, said the state government has built 20 such urban forests in the state since 2003 when the government began celebrating Van Mahotsav.

## Death of three youths in Dahod: Police suspect fatal accident

THE DAHOD district police have begun a probe into the death of three youths from Kapdi village of Dangangya Baria taluka of the district, whose bodies were recovered from Dangangya village in the taluka on Friday. The police said that prima facie investigation and autopsy reports suggest a fatal accident in which the motorcycle on which the three youths were travelling fell into a gorge near the village.

The bodies of Yusuf Ayub Kanaali, 21, Akkar Sattar Patel, 25, and Sameer Jhalaria, 21, were recovered from a gorge near Dangangya village on Friday, along with the motorcycle that they were riding. On Saturday the district police, which is probing allegations of foul play from the families, said that the primary cause appears to be that of a fatal accident.

Dahod Superintendent of Police Ehtesham Jaisas said, "We had sent the bodies for autopsy as no external injury marks were visible. The post-mortem reports have not indicated any other injuries to the body either. Prima facie it does appear to be a fatal accident. But we are investigating all other angles, including the apprehension expressed by the families of the possibility of foul play."

The family of one of the deceased had alleged that the bodies have been killed by the family of a girl he was earlier in a relationship with. Dahod SP Jaisas said, "They have expressed apprehension but the issue of the love affair was a couple of years old. Otherwise, we are awaiting all possibilities. At this point, we do not know how the accident also happened — whether their motorcycle collided with someone or whether they tried to maneuver their way to avoid a collision and fell into the gorge, which is also about 50-feet deep. The curve at which the motorcycle fell is an L-shaped turn. It is likely that they misjudged the turn in the dark and just fell into the gorge. Prima facie, it does not seem to be a case of an accident but we will only know after the forensic reports arrive."

The police have sent the viscera samples of the deceased to the Forensic Science Laboratory to rule out any possibility of foul play.
