SC refuses urgent hearing to Karti's plea

THE SUPREME Court on Thursday refused to give an urgent hearing to Congress leader P Chidambaram's son Karti Chidambaram's plea seeking permission to go abroad.

"It is not so important a matter to be considered tomorrow," a bench of Chief Justice of India Ranjan Gogoi and Justices U U Lalit and K M Joseph remarked when Karti's counsel mentioned the matter at the start of the day's proceedings.

"It is not so important that it will get precedent over other (cases)," the bench said, adding that the judges have more cases "than they can handle".

Soon after taking charge as Chief Justice on October 2, Gogoi made it clear that he would allow only very urgent matters like those involving demolition or deprivation of personal liberty to be mentioned for urgent hearing.

In the past, the apex court on many occasions granted Karti, facing a probe in the INX Media and Aircel Maxis cases, permission to travel abroad.

The CBI had opposed this, saying he may tamper with evi-
