



## RISING CASES OF ATROCITIES ON DALITS

# Govt assures 'stern action', Cong calls it 'hollow promise'

**ENS&PTI** 

AHMEDABAD, MAY 15

IN THE wake of rising incidents of Dalit wedding processions being stopped by upper castes in parts of Gujarat, the BJP government in the state on Wednesday assured to take stern action against such elements.

The Congress, however, said that such "hollow promises" by the government fails to provide "justice" to the Dalits.

Speaking to reporters, Minister of State for Home, Pradeepsinh Jadeja, said, "The Gujarat government is always with the Dalits. They also have the right to take out wedding processions like others. Our government is also concerned about some recent incidents. I want to assure you that stern action will be taken against those who were behind these incidents."

He, however, accused **Opposition Congress of "creat**ing a rift between Dalits and other communities".

"Some people are trying to create a rift between communities for their political gains. At Lhor village, we have already arrested five persons, including the sarpanch, for announcing social boycott of Dalits. Notably, the sarpanch is a Congress supporter. Another accused is a local Congress delegate," the minister added.

He was referring to an incident at Lhor village in Mehsana, where some local leaders, including the sarpanch, gave a call of social boycott after a Dalit groom took out his procession riding on a horse two weeks ago.

Jadeja also urged people from all walks of life to work with the government to establish and preserve social harmony in the society.

Slamming the BJP government over this issue, Gujarat Congress in-charge, Rajeev Satav, claimed that the government only gives hollow promises instead of taking action.

"Atrocities on Dalits in Gujarat have increased in recent years. After every incident, the state government gives hollow promises of stern action. However, Dalits never get justice," Satav told reporters.

"This government has failed to maintain law and order. The administration is being run through remote control from Delhi. This is the reason why such atrocities are on the rise," he said.

Earlier in the day, a Congress delegation, led by Leader of Opposition Paresh Dhanani and former state unit president Arjun Modhwadia, submitted a memorandum to Governor O P Kohli,

On Sunday, police had to resort to a lathicharge after members of the Patidar community allegedly stopped a Dalit man's wedding procession and hurled stones at them, leaving 12 persons injured, including six police personnel.

While police have filed an FIR against unidentified group of 200 people, they have not registered a case against a woman police officer who has been accused by the groom's family of being partisan in her approach.

In another incident the same day, the wedding procession of a Dalit bridegroom at a village in Sabarkantha district had to be provided police cover after members of the Thakor community objected to the groom offering prayers at a local temple. The procession, however, passed off peacefully, police said.

# Communal tension in 2 villages of Vadodara, elders broker peace

AFTER FEW days of communal tension at Hansjipura and Dhaniyavi villages in Vadodara over alleged dumping of poultry farm waste in a pond shared by the two villages, leaders and elders from both the communities got together to resolve the matter on Wednesday.

The tension began after a 51year-old Lakshman Babubhai, a resident of Hansjipura, filed a complaint at Dabhoi police station on Saturday, alleging that he was attacked by two men — Imran and Nizam—from neighbouring Dhaniyavi village when he objected to the dumping of poultry farm waste into the pond since it is a source of drinking water in his village.

Based on his complaint, police had arrested Imran and Nizam. They were later released on bail. Things escalated on Tuesday, when Babubhai complained to police that the duo accompanied by seven others from their village and armed with sticks and sharpedged weapons assaulted him and threatened to kill him.

Police have booked all the nine accused under IPC sections 143 (unlawful assembly), 147 (rioting), 148 (rioting), 506 (2) (criminal intimidation) among others. However, no one has been arrested, so far.

Muslims, on the other hand, have alleged that the Thakor community has been targeting the minority community by falsely accusing them in the case. They have

alleged that the police was pressured to file a complaint against the nine persons as the entire Thakor community members had landed up at Varnama police station to file the complaint.

On Wednesday, they had initially planned to meet the Superintendent of Police and Collector of Vadodara Rural district and submit a memorandum, saying that the men from the community were being falsely accused in the case.

However, before submitting the memorandum, the leaders from both the communities got together and agreed to make a compromise.

"Both the villages are close by, and people have always lived in harmony. The person who has been named as an accused is a very simple man and has never been involved in any such crimes. Our leaders got together and decided that there was no point in escalating the matter and give it a communal colour. So, the Hindus decided that they

will withdraw the case against the accused. Meanwhile, we have also decided that we would not file any cross complaint or submit any memorandum in the case to anyone," a minority community leader from Dhanyavi

told The Indian Express. But with an FIR in place, the process of withdrawing the complaint will not be easy, according to the police.

"Once an FIR has been filed, investigation will be carried out as per the laid down procedure. During the investigation, if the complainant states that the allegations he/she has levied is untrue, then the case can not be proven against the accused. Till then, as per the procedure, police will go ahead with its investigation," said Tarun Duggal, SP of Vadodara Rural.

Meanwhile, police said that there was no law and order problem in the area and security has been beefed in the area with regular patrolling by policemen to avoid any untoward incidents.

MINISTER OF Food & Civil Supplies Jayesh Radadiya on Wednesday said that the government has taken strict actions against those involved in the adulteration of tur dal (pigeon pea) at the Keshod marketing yard in Junagadh by impounding 3,241 bags of the adulterated dal and filing a case against eight persons, of which four have been arrested.

"The low quality tur dal that had arrived at Keshod yard has been seized. These (adulterated) stock did not belong to farmers. The seized stock belonged to traders," the minister said.

Accusing the Opposition Congress of trying to "defame" the government by using the word scam, the minister said, "Congress leaders recently went to Visavadar marketing yard (in Junagadh) and claimed that there was a similar scam in the procurement of 22,000 bags of tur dal from farmers. The government checked all the 22,685 bags of tur dal at the yard and found dal to be of good quality... After the Keshod incident, Congress leaders are trying to portray that similar incidents are happening across the state."

Radadiya said the government has so far procured 33 MT of tur dal from farmers on MSP. Till date, he said. Rs 150 crore has been paid directly to farmers.

# Inquiry on, but minister gives clean chit to GSFC

DESPITE AN inquiry being ordered into how the 50-kg fertiliser bags sold by state-run Gujarat State Fertilizers and Chemicals Limited were found to be weighing less, state Agriculture Minister RC Faldu on Wednesday defended the PSU, saying that no discrepancy have ever been noticed in the history of the 57-year-old company.

"I have to make just one thing clear that GSFC has been manufacturing fertilisers in this state for the last 57 years. There has been no complaints of any kind from any place. There have been no complaints of fertilisers be-

ing taken out of the bags or presence of holes in the bags. No discrepancies have ever been noticed in the past in places where these bags are stitched. Such a big company that has been manufacturing fertiliser in the state and there has been no talk of a scam," Faldu said.

The minister's "clean chit" to GSFC comes just days after the government issued a statement claiming that "prima facie it appears that fertiliser bags were not tampered with and there is no scam related to the underweight bags" of DAP sold by the GSFC.

On Tuesday, the Opposition Congess had termed it as a "huge scam" and demanded registration of FIR against officials of the GSFC.
