**MODIFIES HC ORDER**

**SC accepts plea by APFs**

their marriage under the SMA. A bench of justices Mohan M Shantanagoudar and Sanjiv Khanna modified the High Court order after senior advocate Arundhati Katju, appearing for the couple, told the bench the "the petitioners do not want to get their marriage registered under the Special Marriage Act" and that "if it is so, the court cannot force them to get the marriage registered".

In an order on August 8, the SC bench said: "Recording the said submission made on behalf of the petitioners, the impugned order stands modified to the said extent."

The petitioners married on September 6, 2016, and already had their nikahnama issued after which they approached the High Court for protection as

said "this is a free and democratic country, and once a person becomes a major he or she can marry whosoever he/she likes. If the parents of the boy or girl do not approve of such inter-caste or inter-religious marriage the maximum they can do is that they can cut off social relations with the son or the daughter, but they cannot give threats or commit or instigate acts of violence and cannot harass the person who undergoes such inter-caste or inter-religious marriage".

Advocate Abdul Azeem Kalebudde, who filed the appeal against the HC order, said Muslim marriage is conclusive when a nikahnama is issued and there was no need to register it separately under the Special Marriage Act.

**Former ASG Sharan dead**

New Delhi: Former Additional Solicitor General of India, senior advocate Amarendra Sharan, died after a cardiac arrest on Monday morning in Rishikesh. He was 69. Sharan had reportedly gone to Ananda resorts in Rishikesh for the weekend.

Last year, the Supreme Court had appointed Sharan as amicus curiae to help it on a petition that sought re-investigation into the assassination of Mahatma Gandhi. Sharan had opined against re-opening the probe — "There is no need either of a re-investigation or to constitute a fresh fact-finding commission," he had said. The court accepted his suggestion and dismissed the plea.

He was also amicus curiae in the case in which the apex court delivered the judgment laying down checks before effecting arrest under the Scheduled Tribes
