Your kind attention is invited to Regulation 46 of SEBI LODR Regulations, 2015 which reads as follows:-

- As per regulation 46, the listed entity shall maintain a functional website containing the basic information about the listed entity.
- As per regulation 46(2) of LODR regulations, website of the Company shall contain the details of materiality policy, name of designated officials, latest shareholding pattern, financial results etc (extract of Regulation 46(2) of LODR attached).

In view of the above, it is observed that your Company's web site is not updated and hence you are not complying with the provision of regulation 46 of LODR.

Also note that as per SEBI SOP Circular bearing reference no. SEBI/HO/CFD/CMD/CIR/P/2020/12 dated January 22, 2020 following action is attracted towards non-compliance with the provision of regulation 46 of LODR:

Regulation	Fine payable and/or other action to be taken for non-compliance in respect of listed entity
Regulation 46  Non-compliance with norms pertaining to functional website	Advisory/warning letter per instance of non-compliance per item ₹ 10,000 per instance for every additional advisory/warning letter exceeding the four advisory/ warning letters in a financial year

The Company is directed to provide clarification for the above non-compliance as penal provisions can be attracted with norms pertaining to functional website as per regulation 46 latest by February 3, 2023.

You are further advised to ensure that website is fully functional & updated till date & comply with norms pertaining to Regulation 46 of SEBI LODR Regulations, 2015.
